## NOTICE OF APPLICATION AND HEARING FOR AN ELECTRICITY DISTRIBUTION RATE CHANGE

### Enersource Hydro Mississauga Inc.

Enersource Hydro Mississauga Inc. (“Enersource”) has applied to the Ontario Energy Board (the “Board”) for permission to increase its delivery charges beginning January 1, 2013 and January 1, 2014. The application was filed on April 27, 2012, and updated on May 17, 2012, under section 78 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c.15 (Schedule B).

Delivery charges are one of four regular items on Residential and General Service customers’ electric bills and vary depending on the amount of electricity consumed. **If the application is fully approved as applied for the monthly bill for a Residential customer who consumes 800 kWh per month will increase by about \$6.65 in 2013 followed by a decrease of \$0.40 in 2014. The monthly bill for a General Service customer consuming 2,000 kWh per month and having a monthly demand of less than 50 kW would increase by about \$5.87 in 2013 followed by a further increase of \$4.72 in 2014.** The proposed changes to the Delivery charges are separate from other potential changes to the electricity bills, which are not affected by this application.

A complete copy of your letter of comment, including your name, contact information, and the content of the letter, will be provided to Enersource and the Hearing Panel.

### **Observe**

If you do not wish to actively participate in the proceeding but you do wish to receive documents issued by the Board, you may request observer status. Your written request must be received by the Board no later than **10 days** from the publication or service date of this notice.

### **Personal Information in Letters of Comment and Observer Requests**

All letters of comment or letters requesting observer status will be placed on the public record, which means that the letters can be seen at the Board's offices and will be available on the Board's website. Before placing the letters on the public record, the Board will remove any personal (i.e. not business) contact information from the letters (i.e. the address, fax number, phone number, and e-mail address of the individual). However, the name of the individual and the content of the letter will become part of the public record.
